ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY AMENDING CHAPTER 420 LAND USE PROCEDURES AND CHAPTER 500 ZONING TO PERMIT MICROBREWERIES AND SIMILAR ESTABLISHMENTS IN CERTAIN ZONES OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP

WHEREAS, the Mayor and Township Council has received a request to review whether microbreweries, craft distilleries, brewpubs, and wineries in residential districts with large minimum lot sizes are an appropriate land use within the Township; and

WHEREAS, the Mayor and Township Council wish to encourage agritourism, farming, and related uses within the Township; and

WHEREAS, the Mayor and Township Council have determined that permitting microbreweries and similar establishments as defined herein in appropriate locations would be beneficial to the general welfare of the community; and

NOW THEREFORE, BE IT ORDAINED, by the Township Council of the Township of West Milford, in the County of Passaic, and State of New Jersey as follows:

SECTION 1. Chapter 420 "Land Use Procedures" is amended to read as follows:

§ 420-6 Definitions.

BREWPUB

Microbreweries which are associated with a restaurant.

CRAFT DISTILLERY

A craft distillery is a distillery holding a craft distillery license issued by the State of New Jersey as defined by N.J.S.A. 33:1-10 3d producing up to 20,000 gallons of distilled alcoholic beverages per year. The holder of this license shall be entitled to sell this product at retail to consumers on the licensed premises of the brewery for consumption on the premises, but only in connection with a tour of the distillery, or for consumption off the premises in a quantity of not more than five liters per person, and to offer any person not more than three samples per calendar day for sampling purposes only. Sampling means the gratuitous offering of an open container not exceeding 1/2 ounce serving pursuant to licensure issued by the Director of the State Division of Alcoholic Beverage Control (ABC).

MICROBREWERY

A microbrewery is a brewery holding a limited brewery license issued by the State of New Jersey as defined by N.J.S.A. 33:1-10.1b, producing less than 15,000 barrels of 31 gallons of malt beverage per year. The holder of this license shall be entitled to sell this product at retail to consumers on the licensed premises of the brewery for consumption on the premises, but only in connection with a tour of the brewery, or for consumption off the premises in a quantity of not more than 15.5 fluid gallons per person, and to offer samples for sampling purposes only pursuant to licensure issued by the Director of the State Division of Alcoholic Beverage Control (ABC).

WINERY

A winery is a business operating for consumption of wine on or off the winery's premises, and for sampling purposes for consumption on the premises, in order to showcase New Jersey viniculture when operated by one who holds a license permitting same issued by the Director of the State Division of Alcoholic Beverage Control (ABC) and who operates as permitted by the ABC regulations."

SECTION 2. Chapter 500 "Zoning" is amended to include the following new section as follows:

Article III Residential District

§ 500-8 Principal permitted uses on the land and in buildings.

M. Microbreweries, craft distilleries, brewpubs, and wineries in the R-3 and R-4 Districts on lots greater than or equal to five (5) acres and in accordance with applicable State regulations."

SECTION 3. All ordinances of the Township of West Milford, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

ORDINANCE AMENDING SECTION 15-37 PAY TO PLAY POLICY AWARDING CONTRACTS OF THE CODE OF THE TOWNSHIP OF WEST MILFORD

BE IT ORDAINED, by the Township Council of the Township of West Milford, in the County of Passaic and State of New Jersey, as follows:

- **SECTION 1.** Chapter 15, Administration of Government, Article VII, Office of Administration, Section 15-37, "Pay to Play Policy; Awarding Contracts," Subsection C, "West Milford and county contribution limits affecting vendor eligibility and conflicts of interest," of the Code of the Township of West Milford is hereby amended as follows:
- § 15-37 Pay to play policy; awarding contracts.
- C. West Milford and county contribution limits affecting vendor eligibility and conflicts of interest. Campaign contribution limits affecting the eligibility of vendors, pursuant to Subsections **B** and **D**, to enter into or be paid pursuant to agreements for the purchase of goods or services are as follows:
 - (1) The maximum amount of West Milford campaign contributions that may be made by a vendor to each political organization or campaign committee or fund during any election cycle shall not exceed \$200.
 - (2) The maximum amount of county level campaign contributions that may be made by a vendor to each political organization or campaign committee or fund during any election cycle shall not exceed \$200.
- **SECTION 2.** All ordinances of the Township of West Milford which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 3.** If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.
- **SECTION 4.** This Ordinance may be renumbered for purposes of codification.
- **SECTION 5.** This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.

ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, REPEALING AND REPLACE § 15-7, TO ESTABLISH THE POWERS AND DUTIES OF THE MAYOR AND ESTABLISH TOWNSHIP COUNCIL'S AUTHORITY TO DETERMINE WHETHER THE MAYOR POSITION IS FULL-TIME OR PART-TIME, WITHIN THE CODE OF THE TOWNSHIP OF WEST MILFORD AMENDED

WHEREAS, the Township Council wishes to amend the Township Code to specify the powers and duties of the Mayor and create a new section, which sets forth the Council's authority to determine whether the Township Mayor position is full-time or part-time, at the beginning of any given calendar year; and

WHEREAS, the Township Council further wishes to set forth and specify the duties and responsibilities of a full-time Mayor should that be desired by Township Council; and

WHEREAS, Township Council herein recognizes the need for the Mayor to serve in various capacities and positions, on behalf of the Township and beyond a part-time role.

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of West Milford, Passaic County, New Jersey, that only Section 15-7, Powers and duties of Mayor, shall be repealed in its entirety and replaced as follows:

SECTION 1. §15-7 Powers and duties of Mayor

- A. The executive power of the municipality shall be exercised by the Mayor. The Mayor shall enforce the Charter and ordinances of the municipality and all general laws applicable thereto, and shall recommend such actions to the Council as the Mayor may deem in the public interest. All bonds, notes, deeds, contracts and written obligations of the Township shall be executed on its behalf by the Mayor or, in the event of any inability to act, the Council President.
- B. Should a full-time Mayor be appointed by a majority of Township Council members, the full-time Mayoral duties and responsibilities shall include, but not be limited to:
 - 1. Serving as Township liaison to the State and County on public works and health matters;
 - 2. Managing grants;
 - 3. Overseeing major projects and Township initiatives;
 - 4. Coordinating economic development initiatives;
 - 5. Managing all Township shared services agreements;
 - 6. Managing Township public relations, including social media; and
 - 7. Serving as Joint Insurance Fund and Health Insurance Fund Commissioner.
- **SECTION 2.** All ordinances of the Township of West Milford, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
- **SECTION 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.
- SECTION 4. No provision of this Ordinance shall be construed to impair any common law or statutory cause of action, or legal remedy therefrom, of any person for injury or damage arising from any violation of this Ordinance or from other law.

Melissa Brown-Blaeuer – Was appearing on behalf of 852 petition signers who were opposed to Ordinance 2024-009 and 2024-011. They feel it will have a negative impact, changing the authority of the Mayor on an annual basis and possibly would be an increase in salary of 550% to 900%, over 4 years that could be a half of a million dollars. People across the political spectrum are angry and they are unified in their opposition to having a full-time Mayor. She indicated that people were turned off from volunteering because of all the partisanship. We don't need a full-time Mayor doing administrative work and bloating our budget and no one voted for that in the last election. Ms. Brown-Blaeuer indicated that the full-time Mayor position came about because Mayor Dale recently lost her job. She read the petition. The people who signed it would like to have a referendum. Having a full-time Mayor would benefit the Mayor but not the Township. We do not need two full-time staff administrators. Having a full-time Mayor negates the principle of having a strong and independent executive branch. She indicated that those who signed the petition see no changes happening in Town that show need for a full-time Mayor. The population in West Milford has been declining since 2017 and currently is about 24,382 in 2022. While it is a large Township a lot of land is controlled by other entities. There are other alternatives.

Renee Allessio - Has been a resident for 46 years, volunteers, loves the Town and only speaks at a Council meeting out of concern, not because of any ulterior motive or agenda, as was indicated by someone else at a previous Council meeting about those who spoke against Ordinances 2024-009 and 2024-011. She indicated that she had made a mistake at a prior meeting about the median household income in West Milford being \$75,000 instead of being \$120,000 but added that would mean a two person household individual salary would average out to \$60,000 a person. She referred to Mayor Dale's statement that she and the Administrator are only two people for 80 square miles and feels that remark was disingenuous because the Administrator has two staff members, and the Clerk's office has a Deputy Clerk, two full-time and one part-time staff. She finds the staff knowledgeable and helpful. If only the Mayor and Administrator are doing the job, why are we spending over \$500,000 plus benefits for all of them? Three of these staff members make less than \$60,000 so you can imagine what the rest of them make. It is rare for a Township Administrator to also be the Clerk. He should only be dealing with the Administrative duties and not the duties of the Clerk. She quoted Al Gore. "We are the United States of Amnesia." The Mayor and Council positions used to be volunteer positions with stipends not salaries. Perhaps the Mayor should resign and apply to be the Administrator. Currently our Town government is not a non-partisan type of government. It became extremely partisan in 2002 when the form of government was changed. These two ordinances will have major consequences and should be voted on by the public and not just Council members.

Laura Ashtyani – Has nothing against the Mayor, and feels she is doing the Mayoral duties to the best of her abilities and isn't here to personally attack anyone. She indicated that the ordinance is way out of line because the Mayor has the executive power and the Council has the legislative. Having thousands of dollars in play subject to the Council makes the Mayor consciously or maybe even subconsciously want to please the Council. This is not a system of checks and balances. The position of Mayor is an elected one not an appointed one. She asked the Township Attorney how it is that the Council can legislate an elected position. She asked that they vote no on the ordinance.

Troy Oswald – Does not feel like this a political issue and has seen in Paterson where it worked with a full-time Mayor and a part-time Council. He indicated that he is pleased with the stewardship of the Mayor, and is looking forward to Mayor Dale holding the full-time Mayor position.

Karen Phelan – Mentioned the old saying, "the road to hell is paved with good intentions." Ms. Phelan indicated that there will be a lot of unintended consequences if the ordinance is passed. It will upset our system of checks and balances and we may end up with less qualified candidates and more turnover down the road. This will affect the administrator's job dramatically, essentially the equivalent of adding another full time person. She indicated that there would be impacts on our long term projects, causing delays, new people getting up to speed and wanting to put their own spin on things and the delays will negatively impact the budget. She asked that unintended consequences of these actions be considered.

James Foody – At the February 21, 2024 meeting he asked questions regarding the Wanaque Valley Sewerage Authority and did not get answers on record, but rather after the meeting. He indicated that the Mayor was told in August that she would lose her job in November, and that in December she told people

she would be going for a full-time Mayoral position. If this were based on consent of the governed the issue would be put out to a referendum. He read some passages from the Declaration of Independence. It is the right of the people to alter or abolish or institute a new government whenever any form of government become destructive. He indicated he is in favor of altering the government and getting rid of the Councilmembers. He quoted Thomas Jefferson, "When tyranny becomes law, rebellion becomes duty. When the people are afraid of the government that's tyranny. When the government is afraid of the people that is liberty." The Council should vote no and put a referendum to the people. It's not right to make the Mayor full-time because she lost her job, and if people do it's because somebody must think we are hicks and hillbillies.

Carl Richko - A former Mayor, indicated that he agrees with those who spoke at the last meeting and wanted the issue put to a referendum. There are a lot of people who showed up to this meeting tonight, probably 125 people, so think of that and also the number of people who signed the petition The Council represents the people and should listen to them. He questioned the current need for a full-time Mayor. Mayor Dale has been a part-time Mayor for about 5 years. Why now do we need a full-time Mayor? What has happened in the last few months that makes it so very important that she become full-time? The job of the Mayor and Council is to govern and oversee. The Administrator's job is to handle the daily administration duties of the Town, including dealing with personnel, handling emergencies, working on a budget to present to the Council, overseeing projects and making sure that residents have services available to them. As pointed out in the last meeting, our Administrator has qualifications, so what has happened in the last few months to warrant the need for a full-time Mayor. With regard to a previous speaker comparing West Milford to Paterson, there is no comparison. Paterson has 140,000 people and West Milford has under 25,000. It is unheard of in the State of New Jersey, for a Town of our size to have both a full-time Mayor and a full-time Administrator. Their combined salaries with benefits would exceed \$300,000. As a 62 year resident who loves living in a Town where people care so much he wanted to thank everyone for coming out tonight.

Andrew Gargano – He was on the last Town Council before it went to this form of government. At that time the 5 Council members elected the Mayor annually and the position was always part-time. He was against the change 22 years ago because things occur when there is no bi-partisanship. They acted for the greater good back then and this is not for the greater good it is a grift. He takes issue with the matter having been taken up in executive session. The ordinance should have been taken up in a public meeting and maybe it would have been stopped before it got to this point. Former Mayor Betina Bieri set the bar as Mayor and got a lot of things done on less of a salary then Mayor Dale currently gets. He indicated that this is the dumbest ordinance that the Council has ever come up with and he cannot believe that it has even gotten to this point. It sets a bad precedent for other Towns as well. Mr. Gargano urged the Council to seriously think about this ordinance and vote no.

Robert Nolan – Is a 41 year resident and also a former Councilman. The Mayor of Fairlawn resigned and then became the Administrator for \$175,000, which is in line with what we are currently paying our Administrator, even though Fairlawn has an additional 10,000 residents. Even though a lot of people are here tonight there are also a lot of people who are unable to attend the meeting because we all have busy lives. Estimating a \$120,000 salary and adding the benefits would equal about \$170,000, and while that may be something that works this year, that \$170,000 after five years becomes \$850,000 and would buy a lot of stuff, an ambulance, equipment and a lot of other things. He read some excerpts from some executive session minutes. He asked that if the Council feels what they are trying to do is correct to let the peasants vote on it in November.

Mary Grace Lawson – Has been here since 1970. She indicated that back-door deals were made in the past, mentioning Jungle Habitat, and though she is fine with this newer form of government, she feels that having a full-time Mayor would encourage back-door deals. It should be voted on by the people.

Ted Porebski – Indicated that he views the situation in a simple form. The job of Mayor was taken as a volunteer position to the Township and to then make it a paid position doesn't seem right at this time. He has been listening to what the people have said and how hard the Mayor works and perhaps the Mayor should become the Administrator and then she could have that position for possibly 10 to 15 years. Passing the ordinance today would have a lifespan of 3 plus years and then the Mayor will be voted out. He's not in favor.

John Schaefer – Has been a resident since 2020 and disagrees with the ordinance. Mayor Dale seems like a wonderful person. He indicated he felt he should speak up having a young son at home, because he is not in support and urged the Council to vote no.

Laura Slott – Is here to ask the Council to vote no on Ordinance 2024-009 and 2024-011. The Mayor was elected to be a part-time Mayor with a \$16,000 salary, and there are no more projects now than there was before to justify the change. It would be unjust and unethical. The Town Council should not be voting on a significant matter such as this that benefits one of its own members at the detriment to the people of the Town. She indicated that it would be great if every elected leader had to take servant leadership training. Such an important position should have to be publicly advertised, applied for and not just handed over to the Mayor and she implores the Council to do what is right and vote no.

Chris Garcia – Has heard that the defense of the matter is that it is a personal attack and it is a witch hunt against Mayor Dale. Public policy should be defined and established not based on any individuals. The people who ran for Mayor this past year ran under the expectation that it was a part-time position. At this point why are we changing that expectation because whether it is true or not, it appears that we are dealing from the bottom of the deck and that is upsetting a lot of people. He indicated that it was more of a moral or ethical issue than anything and shouldn't be about any individuals. We should not be basing public policies based on any individual or individual circumstances. It is not good public policy and is not well thought out and it appears to be underhanded. There is a lot of complexity involved with a lot of the projects we have and we need to hire professionals that are qualified and have the experience necessary. It has to do with personnel. People are upset because it is bad public policy, it sets a bad precedent, and it is unethical and immoral. It could have been voted on by the people last November but it wasn't imperative then and now it is. Please do the right thing.

Seeing no one else wishing to speak Councilwoman Erik made a motion to close the public portion. Seconded by Councilman Goodsir.

Councilman Chazukow - thanked everyone for their comments and likes to see this level of public participation. He indicated that he did not have the time to address all of the mistruths and misinformation that needs to be corrected. There is so much misconception and personal attack going on that he can't even begin to address it. Councilman Chazukow pointed out that actions toward Antoinette Battaglia were done by a previous Council not the one acting currently.

There was some back talk from the public and Mayor Dale asked that people be polite. The Council listened to them and if they want their questions answered they will listen respectfully to the Council comments.

Councilman Chazukow - indicated that comments made by the public said more about the individuals making the comments than the merits of the ordinance being discussed. The Council is there to discuss the ordinance and not anyone's personal life. His household income may be about half the average of those in the Township but he tries to relate it to the value of the property. He credited Mayor Dale's leadership with increasing the value of his home 400-500%. He has no doubt that there will be a guaranteed return on the Mayor being full-time. Mayor Dale has brought millions and millions of dollars in grant money into the Township. Every army needs a general and the Mayor's job isn't 9 to 5. It is a full-time job. Consider the area in Hewitt that was abandoned and a ghost town before Mayor Dale's leadership. He sees the improvements that the Mayor has made.

Attorney Semrau – Clarified that the approval of this ordinance does not automatically make the Mayor's position full-time. It makes a full-time position an option but it does not mean that it is approved. There has been a lot of questions about the language of the ordinance regarding that the Council shall determine, by the date of the re-organization meeting. In most forms of government it is the Council that legislates and sets the salaries. The Governing Body can do that at any time. To remove any confusion, Attorney Semrau suggested that the language about the re-organization meeting should be removed. He advised the public keep in mind that the ordinance would provide an opportunity, if it came, to change the structure but does not change the Mayor's position tonight.

Councilman Chazukow has no objection to advertising the job, if that is what Councilmembers want to do. He indicated that should Council go that route it would be based on what the public has expressed seeing rather than what they feel is best and practical for the municipality. Delays only cost more. He would be happy to discuss issues with anyone. The best tactic moving forward is to empower the local government. There is no making government smaller. New Jersey is too far gone.

Councilman Goodsir – Has lived here his entire life and is the volunteer coordinator and Exalted Ruler at the Elks Lodge. He indicated that there are a lot of things going on that the public doesn't know about, and Mayor Dale is the best Mayor the Town has ever had. The ordinance gives the Council options now and in the future to manage the administration of the day to day operations of the Township. The Administrator already serves the role as the Administrator and Clerk and we can utilize his financial background as a CFO to provide additional oversight to the CFO's Office which has a reduction of over \$30,000. If the Council ever determines that there is a need for additional staffing or resources, he wants to have the option to have someone that was elected by the people, who is vested as a resident, is a person that we can consider for those expanding responsibilities. If the Administrator were to leave this ordinance would give us options. We do not have a deputy administrator. People ask what changed. The CFO, a Department Head, is going parttime, and that will save us a lot of money, and Mr. Senande will pick up some of that responsibility. There are things that the Council can't talk about at this time, but in the near future it will become clear why a full-time Mayor is needed. Councilman Goodsir indicated that he isn't crooked or taking part in any back-door deals and as someone who volunteers in the Town he doesn't see a lot of familiar faces.

Councilman Conlon – Indicated that it is not because Councilmembers don't want to talk about certain matters, it's because legally they are not allowed to talk about certain things due to confidentiality constraints. The Mayor and Council are elected to preform fiduciary responsibilities and to ensure that the Township is running as well as it can, given all the factors that come into play. This ordinance doesn't give anyone anything, all it does is give the Governing Body the option to take more time and to access if it is the best way forward. There is no cost to put an ordinance in. There is no cost to the tax payers. There is no cost to the

residents. There's no cost to the municipal corporation. This isn't something that is being rushed through so that the Mayor gets a full-time job in 30 days. He indicated that he also tabled a recent ordinance in order to leave the option it allowed open for future consideration. We have options, we could post a Deputy Administrator job opening and see what qualified applicants we get. There is too much going on and there are too many opportunities to keep kicking the can down the road. The list of projects is available and that list is fluid and it's growing. Councilman Conlon indicated that he would be amenable to having a full-time Mayor, rather than waiting, and posting a job, and seeing who applied, and training them for 3 to 6 months. He is also not opposed to having a referendum, but right now all Council is doing is creating an ordinance to give themselves the option to represent the residents and do the job that the residents elected them to do.

Councilman Marsden – Asked the Township Attorney if the ordinance was to be put through, what the effective date be. Attorney Semrau indicated that the adoption of the ordinance would have to be published and then it would be effective 20 days later. Councilman Marsden is not against having a referendum and appreciates the people who spoke respectfully tonight but not the ones who were disrespectful and threatening.

Mayor Dale – Indicated that she had gone on line to look at the petition, where there were 778 signatures, but it appears there is a discrepancy regarding how many signers are from West Milford zip codes. She is willing to discuss the matter later to be sure she is looking at the correct information.

Councilwoman Erik – Has been attending Council meetings since 1971. She indicated that what happened with Jungle Habitat was not a back-room deal but rather discussed in a public meeting by Committeemen, not Councilmen, and there were a lot of people from Mountain Rise who did not want the park, they voted no and Warner Brothers pulled out. It was not done in the back-room. She takes offense to the notion that this Council is doing deals in the back-room. In answer to the statement that partisan politics is why there is a lack of volunteers, politics has nothing to do with it and there is a shortage of volunteers everywhere. Councilwoman Erik volunteers for a lot and indicated that she doesn't see a lot of people from the audience volunteering. Councilwoman Erik indicated that Councilmembers have to take classes to sit on the dais and deciding to pay \$100,000 for a Mayor is not unethical because they approved \$1,000,000 for a fire truck, but that is because residents really need a fire truck.

Administrator Senande - Indicated when asked that in the four years since he has been here the larger scale projects have ramped up, one of them being the Ridge Road building that has been in the works for years. It would speed up a lot of the projects and they are major projects. The more time these large scale projects take they become more costly. Speeding up projects will significantly save money.

Councilman Goodsir – Indicated that we have received \$200,000 from the TGP compressor station and confirmed with the Township Attorney that the Township would be receiving \$250,000 to \$300,000 more this year from a rateable standpoint. Additionally we received a grant of \$75,000 for the Firefighters.

Councilman Conlon made a motion to move 2024-009. Councilman Goodsir seconded.

Attorney Semrau asked to amend the motion to include the elimination of one sentence in the first whereas paragraph that states that "the township Council shall determine from the date of the reorganization meeting whether a full-time Mayor will be approved for that calendar year" for the purposes of clarification.

Councilman Conlon amended his motion to accommodate the change. Councilman Chazukow seconded.

ORDINANCE OF THE TOWNSHIP OF WEST MILFORD COUNTY OF PASSAIC REPEALING AND REPLACING § 15-5 COMPENSATION TO REFLECT THE SALARY OF A FULL-TIME MAYOR WITHIN THE CODE OF THE TOWNSHIP OF WEST MILFORD

WHEREAS, the Township Council wishes to amend the Township Code to specify annual salary of a full-time Mayor; and

WHEREAS, the current part-time Mayoral salary will not change; and

WHEREAS, the Township Council recognizes that the duties and responsibilities of a full-time Mayor warrant a commensurate full-time salary.

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of West Milford, Passaic County, New Jersey, that only Section 15-5, Compensation, shall be repealed in its entirety and replaced as follows:

SECTION 1. §15-5 Compensation.

- C. The compensation of each member of the Council and Mayor shall be fixed from time to time by Salary Ordinance.
- D. The salary for a full-time Mayor if approved by Township Council shall be within the range of \$90,000.00 to \$135,000.00 per year and subject to the terms and conditions set forth in Township Code §15-7.
- **SECTION 2.** All ordinances of the Township of West Milford, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
- **SECTION 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.
- **SECTION 4.** No provision of this Ordinance shall be construed to impair any common law or statutory cause of action, or legal remedy therefrom, of any person for injury or damage arising from any violation of this Ordinance or from other law.
- **SECTION 5.** This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.
- **SECTION 6.** This Ordinance may be renumbered for codification purposes.

This Ordinance was introduced on February 14, 2024 and Notice of the public hearing was published in the Herald News on February 20, 2024. The Governing Body will open the meeting to the public to speak on this Ordinance only.

Township Attorney Semrau indicated that for the purposes of the record, the previous comments from the public and also Council comments that were made for Ordinance 2024-009 would apply to Ordinance 2024-011.

Councilman Conlon made a motion to apply the previous comments from the discussion of Ordinance 2024-009 to Ordinance 2024-011. Councilman Chazukow seconded.

Laura Ashtyani – Indicated that her comments are not a personal attack on anyone here. She is here because she likes the Town and feels the need to speak. She was offended by the "you people" comment from the Council. The 2022 census places the median income at \$56,631. That is far less than the proposed salary which is \$90,000 to \$135,000. Residents are struggling to make ends meet and they are looking to the Council to make fiscally responsible spending decisions. The current Mayor ran on the campaign of reducing tax burden to the residents and keeping taxes flat. Current staff is capable. She suggested if more help is needed get a part-time Deputy Administrator. At a previous meeting former Mayors and Councilmembers, who are familiar with the Town were in agreement against a full-time Mayor position. We should listen to them. She asked what has happened since the Mayor was elected to warrant the change. Perhaps a reasonable cost of living raise could be given 3.5 to 6.5%. It is not customary to raise someone's pay by 550% and convert a part-time position to full-time. She questioned what would happen to these various projects if it were to be voted down.

John Lauritano – Asked for a referendum so that the correct process would be followed. He indicated that he wanted the people who elected the members of the Council to make the decision, and not the Councilmembers themselves.

Melissa Brown-Blaeuer – Would like to check the website Mayor Dale spoke about regarding the zip codes with Mayor Dale. She indicated that Councilwoman Erik is a good volunteer as well as others are but she has noticed, on the committees served on, that a lot of people are turned off by all the

partisanship. The compensation expands the role of the Mayor and the whole purview. This is not the right way to change an elected office a few months after the election. It's very disturbing to everybody here to have such a change in the money and in the scope of power. If the ordinance isn't going to change anything then why is the Council doing it? We all believe it will come to pass very quickly. Residents feel that it is very unsound and destabilizing and short sighted.

James Foody – Stated he was baffled by the decision that was made. In regard to a comment that was made about what the Mayor has done for the old A&P parking lot. He explained that the building was done through a pilot program where taxes are reduced the County doesn't get any money and the school doesn't get any money and then they have to raise taxes. Mr. Foody indicated that the Town Council already had their minds made up, because a line item has already been placed in the budget for \$120,000 for the Mayor's position. There are no checks and balances because the Council is all of the same party. With regard to a comment Councilman Conlon made about Mayor Dale having the Township in good fiscal standing, \$38,000,000 in gross debt is not a great fiscal position. Under Democratic Mayor Bieri the debt was \$10,000,000 and that number ballooned up once the Republicans took over. The Council will see the repercussions of their actions.

Andrew Gargano – Indicated that he was volunteering in this Town a long time ago, and he built the PAL building. He served on the Council and then on the Library Board and things got done, a lot of it on a volunteer basis and under the oversight of Mayor Betina Bieri on a lower salary. It's a slight against people to say they don't volunteer and he agrees that what Ms. Brown-Blaeuer said about the partisanship being a factor. The passage of these ordinances appears to be a foregone conclusion. The full-time Mayor position is unwarranted and people will step up and get things done. He did it for no pay but rather, just for the betterment of the Town. The matter should have been addressed in public. It's fine that it was discussed in executive session but it should have been addressed in the public view as things were done in the past. It is an affront to the Township.

Susan inaudible – Questioned what a Mayor actually does and what Mayor Dale's additional responsibilities would be should she become a full-time Mayor.

Isaella Walczak – Is a three year resident of West Milford and understands that people are passionate, but reacting, discrediting, and dismissing the community is what she is hearing. She is on the fence with how she feels and sees both sides. We are all a community together and she would like to hear a little more grace from the Council because the reaction and aggression is offensive.

Seeing no one wishing to speak Councilwoman Erik made a motion to close the public portion. Seconded by Councilman Conlon.

Mayor Dale – Indicated that she was addressing the public not as a Mayor who was elected as a Republican, but as a representative of all of the people who have entrusted her with the responsibility to lead the Township. Mayor Dale resigned from her position as the leader of the Republican party when she was elected Mayor because she feels she represents everyone. She stated that her message pertains to any and all matters about which this or future Governing Bodies will make decisions. She indicated that it is with a heavy heart that she is addressing the public concerning propaganda that has been spread in our Township specifically the dissemination of misinformation and deliberate deception by some of our fellow citizens, particularly those from the opposite political party to how I was elected to serve. She is disheartened to witness the spreading of falsehoods and misrepresentations that aim to sow discord to confusion within the community. It undermines democracy and erodes the trust that form the foundation of our society. We cannot allow ourselves to be divided by deceit that has been presented on this matter or any matter, past, present, or future.

She implored those who have engaged in spreading misinformation to reflect on the consequences of their actions. We must hold ourselves to a higher standard, grounded in respect and based on accurate information. We must remember that we are all members of this community, with a shared responsibility to uphold the principles of democracy and work together towards the common good. We may have different opinions but there needs to be constructive dialogue and mutual respect. The opposition to this matter rand any other is not the issue here, rather, the problem in this matter stems from the misinformation being dispersed and making personal attacks aimed to settle political scores and push a partisan agenda.

Mayor Dale indicated that she had comments transcribed from prior meetings, using her own funds, so that she can answer each one factually. "Where did the money from the TGP Compressor station, why they didn't fight for the people against polluting an entirely clean community". We have gone over that. "The people of West Milford voted in 2002 for a partisan form of government with a part-time Mayor." Mayor Dale told people to look at the Faulkner Act, which says nothing about a Mayor being full-time or part-time, but rather says what the duties of a Mayor, Administrator and Council are by definition of the statute.

"I am personally sick and tired of local partisan politics and would love someone who represents me and my district." Mayor Dale indicated that both the Democratic and Republican parties have 2 elected committee members for each of the 13 voting districts who represent them in their district. These elected

party officials are on the ballot and are voted for just like any other candidate. To state that you don't have representation in your district is a completely false statement. You have elected party representation, more representation than you would have in a ward style of government. In the ward style of government we also saw much division. Each representative would work for their ward and not for the greater good of the entire Township. The Mayor and Council work for the whole Township not just their districts, which ensures that decisions are made with the entire Township in mind. There is direct accountability to all the residents.

"My main reason for coming tonight is the restructuring of the health department. You are getting rid of one of the most consummate professionals in the state of New Jersey." Which was basically alluding to the fact that the Council was restructuring the Health Department to pay for a full-time Mayor. The fact is the shared services agreement for the Health Department was entered into in 2019. It is a matter of public record should anyone wish to see it. The final piece of it was entered into in July of 2023.

"We don't' need a full-time Mayor." Mayor Dale is not advocating for or against it. The Faulkner Act actually states that the Mayor is the CEO of the municipality. It is up to each municipality to decide if the Mayor is full-time or part-time.

Mayor Dale gave other examples and indicated that she will be posting all of the examples on her web page for anyone interested but continued by saying that a resident at the last meeting said the position "to benefit an elected official who may be having known financial problems." Mayor Dale disclosed that she has over \$600,000 available to her tomorrow. There were screen shots of her bank accounts and the numbers do not include her real estate holdings.

Mayor Dale reached out to former Mayor Bieri regarding what was said in public regarding what she thought about a full-time Mayor position and she indicated she had been misrepresented. The person that claimed to have spoken to the previous Mayor did not tell the whole story. Mayor Dale had many such examples that she will post and make available.

Mayor Dale indicated that we cannot replace or hire a full-time Clerk because our Administrator who serves in both capacities is tenured as the Clerk. The point is that options have been thought about but that one can't happen. Currently the form of government is not a "Mayor strong" form of government. Mayor Dale cannot appoint a department head without the advice and consent of the Council. She can't move a dime without the Council's consent. Saying that the Mayor will be stripped of her power, doesn't make any sense. If you are against an issue, base the reasons in fact.

In response to a Democratic web page, the powers of the Mayor and the powers of the Council will remain the same. The fox is not guarding the hen house. Attorney Semrau confirmed that the powers would remain the same. There is no bait and switch. Council can change the Mayor's salary tomorrow. Council can change the salary of any uncontracted employee tomorrow. There is no form of government where the public votes on what the Mayor's salary should be. Since 2015 the prior Clerk also served as Administrator in a dual role on and off.

Mayor Dale listed a number of statistics about West Milford and read portions of the Faulkner Act. Mayor Dale listed a number of "Mayor Dale Said..." quotes. Stop wasting tax dollars, in regard to delays that we have experienced that have already cost us a million dollars; Address the long overdue need to improve our sports facilities in order to create a community that attracts families, drives our home values, and provides the community with a home town to be proud of; Get our employees out of the basement of Town Hall; Get a message board in the Newfoundland area so that our residents across the vast 81 square miles can get the same notification as those who pass or live within Town center; Follow the traffic study that had been ousted because of previous politics that identified Lakeside and Greenwood Lake Turnpike as the #1 area in need of a light done, and reduce accidents and near accidents; Take care of our Senior population and provide them with a center so that they are not bounced around Town to participate in the nutrition program and other services; Address the flooding of Bradrick Lane, something that should have been addressed 20 years ago. Mayor Dale indicated that the pilot program previously discussed contained misinformation. It is false that no money goes to the County. We do not educate people with funds from commercial space. The program was a way to attract business and revitalize an entire section of Town. It also allowed the Township to retain 95% of the tax dollars instead of sending them everywhere else. The list went on and was extensive and is available through Mayor Dale's web page.

Mayor Dale explained that she has had to deal with many operational issues that were not even started by the current Council. Many more hours were dedicated, more than what would be expected of a full-time Mayor, let alone a part-time Mayor. Due to confidentiality constraints, the nature of the matters cannot be elaborated upon. Administrator Senande and Township Attorney Semrau confirmed Mayor Dale's statement was factual. The Township Attorney indicated that Mayor Dale walked into these matters and has been dealing with the ongoing circumstances and the matters are dealt with during the day and have required travel.

Mayor Dale read a post from James Foody, that said that people should check out who the Mayor has appointed. The Recreation Director was related to her son's father, she gave another job to a relative of her child's father in the Planning Department. She gave one of her good friends a job in the Building Department.

Did you know she got rid of Mr. Lupo in the Zoning Department, and said we only needed part-timers and then fired them and gave the job to former Councilwoman Gerst's husband who got his certificate while the part-timers were here. She handed former Councilman McGuinness's daughter's boyfriend a job to replace the parks and rec director's secretary who just retired. She has turned the employee roster of West Milford into her own friends and family plan. This crap has to stop. Shouldn't it be the most qualified person for the job not her friends or politically connected. Check out what the parks and rec director is making and he came here with no experience.

Councilman Goodsir – Is the liaison to the Recreation Department, and he indicated that Dan Kochakji is one of the greatest human beings he has ever met. He cares about the Town. He recalled when they went out and measured spots 6' apart around Westbrook Park on a Sunday for the trout derby.

Mayor Dale continued with her response to Mr. Foody stating that the employee that was hired as the Zoning officer had volunteered on the Board of Adjustment for 12 years and became certified using his own funds. He is a West Milford resident and although the Township advertised the job, no one else applied. Prior to that the Town had entered into a shared services agreement at an annual cost of \$98,516.25. The head of the Building Department said that wasn't working and requested the Township hire another full-time permanent Zoning Officer. This employee was hired at \$79,595 a savings to the Township of \$18,920.97. He also didn't need benefits so that saved an additional \$25,000. Total savings for the Township \$43,920.97.

The Recreation Director is another lifelong West Milford resident. He has a Masters Degree in Education. His starting salary was \$80,000 which saved the Township \$19,000. The Township has received numerous accolades about his leadership and performance.

The Planning Department employee job was not created. Another employee was promoted to another department. The Planning Department employee had worked extensively in the private sector and was familiar with planning boards and zoning boards and the application process. The employee was offered \$42,050 and then the Township combined what used to be two employees performing the same functions for both the Planning and Zoning Boards to one role and this individual now serves as the secretary to both boards saving \$44,074.72.

The Building Department keyboard clerk started off as a floater and at the request of the Building Department head was made a part-time permanent employee due to the work load in the department, at an annual salary of \$24,122.28 and later due to work load and the Department Head request, this employee was made a full-time employee at a rate of \$24.90 an hour or annual salary of \$45,324.81. The Department Head specifically requested this individual. There's no need for benefits, saving an additional \$25,000, a total annual savings of \$132,895.69.

We have had 8 years of no additional tax increase. The breakdown of what taxpayer money is spent on is included with your tax bill every year in the form of a colorful pamphlet.

Mayor Dale thanked the previous Mayors for being at the meetings. Those Mayors were not elected by the public but were placed as Mayors by Council because that was the form of government at the time. A great deal has changed since the former Mayors served. Mayor Dale asked Attorney Semrau if this governing body can change our form of government without a public referendum and he answered no. Attorney Semrau confirmed that the Council sets the Mayor's salary now and only the Council is allowed to set it in the future. The Council is not doing anything illegal, the Council has the right to adopt ordinances, salary ranges, and descriptions of responsibilities. The Mayor the CEO of the Township and responsible 24 x 7 throughout the entire term. The Council cannot decide if the Mayor will be the Mayor from year to year. It does not change the powers of the Mayor or the Council. Council has always had the power regarding salaries and legislation. Attorney Semrau indicated that one possible change for example might be that if the Council voted to change the Mayor's salary, the Mayor may have a conflict were she may try to veto the motion, due to it having a direct impact upon the Mayor.

For the record Mayor Dale listed the current projects: The traffic light; Address all current and outdated ordinances; Rt 23 communications board; Relocating Parks and OEM from Johner; Senior Building redevelopment; Dygos Field redevelopment; Completing the Ridge Road building; Online permitting/payment; Replacing the septic system for the municipal complex; Relocating staff and records to the Ridge Road building in Town Hall; Greenway Trail/Connecting business district; State bear-proof trash can pilot program; Redeveloping 301 Marshall Hill Road; Replacement of directional signage; Rt 23 Bridge; Address legislation

Mayor Dale indicated that if you don't like something, or don't feel that we need it that is fine, but don't put out propaganda that divides us. Mayor Dale indicated that she will continue to do the job she was elected to do in a non-partisan way.

Councilman Conlon indicated that Mayor Dale was very thorough with her explanation and the public is better informed now than they were, regardless if they are for or against the ordinance. Councilman Conlon indicated that the salary range was comparable to a Deputy Administrator position and Administrator Senande indicated that it was comparable to a Department Head position.

Councilman Marsden indicated that sometimes you get what you pay for and after hearing her explanation, that is why you want someone who knows what they are doing running things. If it came to a referendum that would be fine.

Councilman Chazukow indicated that when he used the term you people he did not mean it in a derogatory way. He thanked the Mayor for taking the time to explain everything, because that will serve the people who put forth honest objections and concerns. When he said before about not making the time to talk, he meant that no amount of facts or explanation is going to clarify anything for someone who is committed to misunderstanding opposing us. He is available to anyone who has any questions.

Councilwoman Erik made a motion to move 2024-011. Councilman Goodsir seconded.

Laura Ashtyani – Indicated that in the Faulkner Act it says that the Council has no administrative duties and no appointive power. She questioned that if the Council were to choose every year if the Mayor was to be part-time or full-time actually be considered an appointive power. Township Attorney Semrau indicated that it is not giving the Governing Body any appointive authority per law. It still stays within the Governing Body's legislative and spending authority. With respect to appointments as indicated, all appointments are either by the Mayor's appointment with advice and consent of the Council or through administration. It is still not considered an appointment it is salaries and legislative.

Carl Richko – A former Mayor, spoke in defense of the older Mayors. Times have changed, but there are always issues to deal with. Perhaps times haven't changed all that much in West Milford. We were made a watershed Town about 130 years ago. He indicated that he felt bad about all the misinformation that is out there. He indicated that when he met with the former Mayors recently they came up with two main reasons why they didn't think that West Milford needed a full-time Mayor. One reason is that the population has decreased over the last 20 years. The second reason is that there is no threat that major development is going to happen in West Milford so there is no need for a full-time Mayor. There are only 45 out of 565 municipalities that have a full-time Mayor. For Towns with a populations under 50,000 there is no such thing as a full-time Mayor. We have less than 25,000 so that was the concern of the prior Mayors.

Melissa Brown-Blaeuer – The partisan form of government that we have here is the fundamental problem. Everyone on the dais is a republican and that innately invokes the national rhetoric and people just vote the party line. It has gotten extreme. Our form of government is becoming authoritarian. The grass roots level is where we can restore the we in "we the people". Please pass an ordinance to initiate the process to return to non-partisan ward based government because that is in the best interest for all of us. We need to restore the integrity and the accountability of all our elected. There needs to be more inclusion and that will encourage more volunteers.

Robert Nolan – Has been to a lot of Council meetings and doesn't appreciate being lectured to. There are a couple of resolutions regarding non-profits regarding block grants on the agenda and he questioned if the addresses of the group homes should be in the resolutions. He used to be a CFO for a non-profit and that is why he questioned it. He referred to the meeting schedule again and how for 6 months of the year there will only be one meeting a month. Mayor Dale had indicated that the Governing Body is efficient and they only need to meet once a month. By law the Governing Body has to meet once a month. He questioned that if the Mayor and Council only need to meet once a month, do we really need a full-time Mayor. Mayor Dale previously indicated that there were also five meetings in a five week time period recently and he indicated that one meeting was about three minutes long so he didn't think that one should count.

John Trojanowski – Indicated that while people should defend their positions, not even 5% of the people signed the petition. He votes every year and sees democratic and republican candidates and he asked why a democratic candidate cannot get elected in this Town.

Seeing no one else wishing to speak Councilman Conlon made a motion to close the public comment portion. Councilwoman Lichtenberg seconded. All were in favor.

Council Comments

Mayor Dale – Insisted that nothing that is done or the decisions being made on the dais have anything to do with partisanship. Ms. Brown-Blaeuer has been appointed to any position she has sought and Mayor Dale would like to discuss this issue with her one on one. Mayor Dale does not like that the population of the Town has diminished and feels it's an issue and not something to be proud of. Mayor Dale indicated that other people, non-republicans, have approached her and asked her to go with them to the County and she went with them because she felt what they were trying to do was best for the Township.

Councilman Goodsir – Indicated that he doesn't care about what a person's political affiliation is, and is willing to work with anyone who wants to be a volunteer. Trump and some of these other topics don't apply here.

Councilwoman Erik – Pointed out that she worked to have Chris Garcia, a staunch democrat, remain on the Planning Board when he was going to quit and he is still on the Board today.

Councilman Chazukow – Indicated that people who feel that there is partisanship should be volunteering and participating so that they can have their voices heard and take part in shaping the Town. People can't say I'm not going to participate because they're not going to listen to me. Either show up or learn to like it.

Councilman Conlon – There are more unaffiliated voters in this Town than affiliated ones. There have been democratic Mayors and Councilmembers in the past. He doesn't understand what national issues are infiltrating down into our local West Milford politics. We may appear to be chummy up on the dais, but that is because we have been working in the trenches together for some time now, and when you do that you see the true character of people. It's not whether you have an R or a D next to your name. If the will of the residents is to have a referendum, then go through the steps and do it.

Councilman Marsden – Stressed the importance of time, and that we don't get it back. He tries to serve the community to make it a better place for his children and grandchildren. There are tough things coming up in the Country and we are going to have to work together to get things done.

Councilman Chazukow – Indicated that although the Mayor and Council have some meetings schedule for once a month, the work that gets done doesn't all happen during the meetings, it happens 24/7. From his perspective, he doesn't see a decline in the population. The once vacant properties around his neighborhood are filled. Also, the population is not the reason we need a full-time Mayor, it's all the projects the Mayor just listed and the amount of work that needs to be done.

Township Attorney Semrau – Indicated that in regard to a comment made that because of the lack of development that can be done, there isn't as much work to be done. However, working around these restrictions actually makes more work. There are more challenges and work involved when you are dealing with an area in the Highlands Preservation. He worked on the Library project, made numerous trips to Trenton, and it applies to all facets, whether it's environmental regulations, street sweeping, salt, clean-ups for properties, access issues, whatever it is it requires greater effort overall to maintain a Township within those boundaries. Attorney Semrau indicated that if you're going to speak about an employee's performance they have to have notice and that will take place in executive session unless the employee wants it public. If you want to speak about a full-time Mayor position, that may be done at any time. Employee evaluations are done on a regular basis, but not in a public meeting. Employees have certain processes and certain rights. In answer to a statement made earlier tonight, one example of a Town with a full-time Mayor and a lower population that comes to mind is Woodbridge with a population around 21,000.

Councilwoman Erik – Mentioned that when you kick the can down the road you end up paying more. Ten years ago, we bought a fire truck for \$500,000 and we just bought the same truck for a million.

Mayor Dale requested everyone take a five minute break. Motion by Councilman Conlon. Seconded by Councilwoman Erik. All were in favor.

The meeting resumed at 10:03 p.m.
