The Township of West Milford is a duly organized municipal corporation of the State of New Jersey.

The Township wishes to intervene as a party in connection with Tennessee's East 300 Upgrade Project ("Project"), Docket No. CP20-493, a portion of which is sited in West Milford, New Jersey, because it has an interest in the Project based upon the significant environmental

implications and impacts of such a project, the impact upon the residents of West Milford and

the impact upon the Township itself. The Township has immediate interests in regard to the

Project and its participation in these proceedings is necessary to serve the public interest.

Specifically, the Township of West Milford seeks to intervene on the basis that the

proposed Project contemplates Tennessee's purchase of property located within West Milford in

order to construct "one new electric-driven compressor station, identified as CS 327, along

Tennessee's existing 300 Line in the Township of West Milford in Passaic County, New Jersey."

The Project also contemplates the installation of a new, 19,000 hp electric motor driven

compressor unit, along with auxiliary facilities and taps to connect to the existing 300 Line with

suction and discharge lines and appurtenances.

For all of these reasons, and others that will be presented in these proceedings, the

Township of West Milford respectfully requests intervenor status in this matter as a party so that

its interests, and the interests of the residents of West Milford, are appropriately represented and

it has the opportunity to be heard on significant issues that affect it and its residents and

taxpayers. Accordingly, the Township of West Milford requests that FERC designate it a party,

with full rights and obligations to participate in conferences, discovery, testimony and cross-

examination, and to be heard on all issues before the Commission.

WHEREFORE, for all of the foregoing, the Township of West Milford respectfully

moves to intervene in this proceeding.
