- A floor plan drawn to scale (minimum ¼ inch = 1 foot) showing locations of equipment, plumbing, ventilation and seating capacity including self-service hot and cold holding units with sneeze guards;
- 3) Finish schedule (construction materials) for the floor, baseboard coving, walls, and ceiling;
- 4) Manufacturer specification sheets for each piece of equipment shown on the floor plan.
- 5) A current copy of the NJDEP Bureau of Safe Drinking Water Transient Non-Community Water System inspection report for the well water supply. For further information, contact the Passaic County Department of Health at 973-225-3646.
- 6) A West Milford Township Septic tank pumping permit issued within the last 3 years.
- 7) If you sell milk, you must apply for a NJ Department of Agriculture Retail Store Milk License. An application can be obtained at: www.state.nj.us/agriculture/divisions/md/prog/dairy.html.

As per the Code of the Township of West Milford Chapter 163-2: It shall be unlawful for any person to conduct a retail food establishment without complying with all of the retail food establishment provisions of the State Sanitary Code as set forth in N.J.A.C. 8:24-1.1 et seq.
