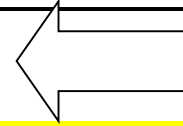

**SIGNS.** All persons are prohibited from making, causing to be made or erecting signs other than those signs provided by the Township of West Milford. Said signs shall be made available by the Township of West Milford and shall be uniform size and form (24" x 24") and **must be purchased from the township.** Said signs shall have a space allotted thereon upon which shall be placed the name and address or the person running the sale and said signs shall be removed within 48 hours after the completion of said sale. **Signs MAY NOT BE PLACED ON UTILITY AND TELEPHONE POLES.** Signs may only be placed on trees with permission of the owner.

**Enforcement by the Zoning Administrator.** This ordinance shall be enforced by the Zoning Administrator. It shall be the duty of the Zoning Administrator to investigate any violations of this ordinance coming to his attention, whether by complaint or arising from his own knowledge, and if a violation is found to exist, he shall prosecute a complaint before the local Municipal Court pursuant to the provisions of this Ordinance. It shall be the duty of the Department of Police of the Township of West Milford, in the County of Passaic, to bring to the attention of the Zoning Administrator for further investigation any violations of this Ordinance of which the Department of Police becomes aware during the course of its normal duties.
