## CONDITIONS OF APPROVAL:

- 1. SOIL EROSION AND SEDIMENT CONTROL DEVICES MUST BE IN PLACE PRIOR TO THE COMMENCEMENT OF ANY SOIL REMOVAL, FILL OR MOVEMENT OPERATIONS INCLUDING FILTER FABRIC FENCE, STONE WHEEL CLEANING BLANKET AND ALL REQUIREMENTS OF THE HUDSON, ESSEX, PASSAIC SOIL CONSERVATION DISTRICT (HEPSCD). <u>http://www.hepsoilnj.org</u>
- 2. THE MAXIMUM ALLOWABLE FINAL GRADE SHALL NOT EXCEED THOSE PERMITTED BY THE MOST CURRENT REVISED THE STANDARDS FOR SOIL EROSION AND SEDIMENT CONTROL IN NEW JERSEY.
- 3. A COPY OF A SURVEY DELINEATING THE LIMIT OF DISTURBANCE AND PROPOSED WORK SHALL BE PROVIDED.
- 4. A COMPLETED ACKNOWLEDGEMENT OF ENVIRONMENTAL CONSTRAINTS SHALL BE PROVIDED.
- 5. A COMPLETED ACCEPTABLE SOIL/FILL MATERIAL CERTIFICATION FORM SHALL BE PROVIDED.
- 6. ANY DISTURBANCE LESS THAN 5,000 SQUARE FEET OF THE SURFACE AREA OF LAND WILL REQUIRE A DETERMINATION OF NON-APPLICABILITY BY THE HUDSON, ESSEX, PASSAIC SOIL CONSERVATION DISTRICT. DISTURBANCE OF MORE THAN 5,000 SQUARE FEET WILL REQUIRE A PLAN FOR SOIL EROSION AND SEDIMENT CONTROL CERTIFIED BY THE SAME. THE PLAN MUST BE PREPARED BY A LICENSED NEW JERSEY PROFESSIONAL ENGINEER (PE) OR A NEW JERSEY REGISTERED ARCHITECT (RA).
