# MINUTES **July 12, 2004**

### **MINUTES**

Motion made by Daniel Kochakji, seconded by Timothy Metcalf, to approve the minutes of the April 5, 2004 meeting. On voice vote all were in favor.

Motion made by Les Lynn, seconded by Daniel Kochakji, to approve the minutes of the June 7, 2004 meeting. On voice vote all were in favor.

#### **APPLICATIONS**

CARL BIERWAS, MINOR SUBDIVISION #0410-1964, Bulk Variance #0430-0665, Block 8201; Lot 2, 1945 Macopin Road; R-1 Zone. Site inspection was conducted by the Commission. The members had no objections to this application. However, they did request that the percent of disturbance be clarified.

MICHAEL & JOSEPH COSTELLO, BRADLEY MALAVOLTA, Minor Subdivision #0310-1956, Block 6403; Lot 1.02, Lincoln & Tintle Avenues; R-1 Zone. The applicants were present. The Commission accepted this application contingent on a review of the Letter of Interpretation and provided that the necessary permits are obtained from the DEP.

**THOMAS A. CELANO, Minor Subdivision #0410-1960, Variance #0430-0669,** Block 5309; Lot 1, Cahill Cross Road; R-2 Zone. The applicant was present. It was determined that a site inspection should be conducted to determine the presence/absence of wetlands and the results e-mailed to the Commission members for recommendation to the Board.

EUGENE PRAIS, Preliminary Subdivision #0410-1961, Variance #0430-0654, *De Minimis* Exception, Block 8401; Lots 22 and 23, 114 Dockerty Hollow Road; R-2 Zone. The applicant was present. Commission had no concerns provided development occurs outside the wetlands.

# **TELECOMMUNICATIONS FACILITIES**

OMNIPOINT COMMUNICATIONS, INC., Use Variance No. 0440-0678, Preliminary & Final Site Plan #0420-0184AB, Block 6404; Lot 1.01, 1832 Greenwood Lake Turnpike; CC Zone. Applicant's representatives, Peter Broy, Czura, Stilwell LLC, Nicole Salerno, Omnipoint and Todd Hay, Dewberry-Goodkind, Inc. were present. Members expressed concern regarding the height of the pole and its proposed camouflage. It was determined that no recommendation would be made until the staff had finished their review.

OMNIPOINT COMMUNICATIONS, INC., (WATER TREATMENT PLANT), Use Variance #0440-0681, Preliminary & Final Site Plan #0420-0186AB Block 14102; Lot 1, Center Island, Route 23. Waiver of EIS previously granted. Members had no further comments.

#### **GRANTS**

Environmental Services Program (ESP) Grant: Storm drain inventory – Phase 2 – Progress report. Rob Sparkes reported that the summer intern, Erick Halvorson, has started working on the project. All the inlets have been mapped, which will complete last year's grant. Work starting on the outfalls. Information to be shared with the County Engineer. Steve Sangle suggested that the inventory of the lake communities should be conducted in the fall after the lakes are lowered. It was noted that all outfalls will be photographs and inventoried.

#### **OLD BUSINESS**

**WATERSHED MANAGEMENT AREA 3:** No report.

**ENVIRONMENTAL BOARDWALK:** Daniel Kochakji reported that the water had receded and that the boards appear to be ruined. Members requested that Custom Dock, the installer, be contacted to assess the situation and advise as to how it could be repaired. The Commission further requested that they be advised when he would be available so that they could be present during the evaluation. It was also suggested that the manufacturer of the boardwalk material be contacted for advice on what caused the buckling and how to remedy the situation.

**DRAFT OPEN SPACE PLAN:** Subcommittee meeting scheduled for July 20<sup>th</sup> to prioritize identified lands.

#### **NEW BUSINESS**

**POST BROOK 319H STORMWATER MANAGEMENT GRANT:** Irene Smith appointed the Commission's representative to Township Committee.

**BELCHERS CREEK:** Members discussed the water test results provided by the Health Department. The Commission suggested that further testing be conducted and requested that an update be provided each month on the progress of said testing. The issue of septic systems and sewers was further discussed. It was suggested that Joseph Elcavage be invited to a future meeting to discuss this issue.
