Ordinance 2021-013 (Defeated): Planning & Zoning Recommendations Administrator Senande said that the draft ordinance had been changed by the Township Planner to say that if residents could provide proof that containers were pre-existing that they could be grandfathered. Councilman Marsden guestioned if there were more than one container would that be allowed and also had safety concerns. He recommended that there needed to be a way to let everyone know about the change and the opportunity to be grandfathered before a deadline, perhaps a mass mailing, he would have to give it some thought. The Ordinance does not apply to farms. Councilwoman Erik asked how "hazardous material" is defined, hers contain hay and hay is 1. flammable. Mayor Dale asked what other towns were doing. Councilman Marsden indicated that West Milford is unique, that people have more land and that certain container usage depending on the property may not provide an eyesore to a neighbor or someone traveling along the road. Administrator Senande suggested we move on to other aspects of the ordinance since these issues related specifically to the container portion. Councilman Gross said he didn't think that shipping containers should be allowed in residential areas at all. He noted that these containers seem to multiply. Administrator Senande indicated that the shipping containers were an issue in Town and that was something that needed to be addressed and suggested that the shipping container portion be reviewed and readdressed. The consensus was to review the Ordinance further. Draft Ordinance: Chapter 500 "Zoning" New Section Entitled Medical and Recreational Cannabis Activity. Administrator Senande said some minor changes had been made, including a \$500 discount for Veterans and a \$500 discount for microbusinesses. The application fee is \$2500 for the first year and then \$1500 for the renewal, and that would apply to every class. The license limit is ten per class, but could be changed. The State has limited the large scale growers to 37 but there is no limit on the microbusinesses. 2. Township Attorney Pasternak indicated that not all definitions were in this draft, some were covered in the first draft. Councilman Chazukow is not in favor of prohibiting cannabis consumption areas, but is in favor of a "bud bar" where people are allowed to smoke. He feels that businesses should be able to get up and running without waiting for the Council to fine tune things. Attorney Pasternak indicated that every town appears to be handling things differently.

Certain things may be addressed in the no smoking ordinance, there are different ways to

Public Comments

Mayor Dale opened the meeting to the public after advising that there is a five-minute limit for each speaker.

Charlene Stoub - 1640 Macopin Road, she called it a "Highway", and would like the speed limit lowered to 35 miles an hour because cars are speeding excessively as they pass her house and her driveway is unsafe to the point where family and friends do not want to visit and risk an accident. The speed limit is higher in some areas along Macopin Road and lower in other places and no one does the speed limit. Perhaps there could be more of a police presence.

Michael Garreau - 1639 Macopin Road, agreed with everything his neighbor Charlene had said and though it is difficult to judge speed, he has to step back from the road because vehicles are going so fast. He is aware that the County has been asked in the past to lower the speed limit and for some reason refused. He suggested if the County denies a request for a speed limit decrease, perhaps a flashing sign or adding cameras onto school buses or on the sign itself.

Administrator Senande said that the Police Chief and Engineer have already looked at it some time ago and he would follow up with them. Mayor Dale also recommended a heightened patrol.

Richard Randazzo - 278 Wooley Road, was not going to discuss the noise ordinance again, though he feels it is very simple, no commercial work on Sunday, no special enforcement just call the police if it happens. Regarding the cannabis ordinance, he recalled individuals on the Planning Board that had to recuse themselves because of a conflicts of interest when a new development was being put in. One individual because they lived next to the organization doing the development and the other because they belonged to Skylands Clean, and there was a DEP conflict. These people were removed from the Board for these matters and he was unsure if it was for a legal reason or an ethical one. Mr. Randazzo said his question was for the Township Attorney and he asked if there was anyone on the Council involved with or planning to be involved with the marijuana business and wondered if that was legally allowed or considered ethical to be voting on the matter. Concern was expressed that a mistake here "could come back and bite" the Township. Mr. Randazzo also indicated that he had recently been to Washington and Colorado and people are smoking everywhere, and the State loves it because of the 10% revenue they were getting from taxes. In New Jersey, we would be receiving less than 7% and a portion of that would also be going to the County. He made the suggestion that the members take a trip out to see how the legalized shops are run. Mr. Randazzo also said he was upset because his property taxes have continued to go up, and he is quite sure that the revenue gained from the legalization will not lower anyone's property taxes. As a substitute teacher, he is worried that the students are going to show up at school, high and smelling like pot. He referred to the speed limit discussion and asked what about everyone coming into West Milford to buy weed.

There being no one else wishing to be heard, Councilwoman Erik made a motion, seconded by Councilwoman Lichtenberg and carried by unanimous voice vote to close the public comment period.

She mentioned that there is a requirement for new homes built on Macopin Road to share a driveway. The reason for this is because the County said it is too congested and they don't want more driveways

ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, AMENDING CHAPTER 470, SUBDIVISION OF LAND AND SITE PLAN REVIEW, ARTICLE XX WIRELESS TELECOMMUNICATIONS FACILITIES TO CREATE A PRIORITY OF LOCATIONS FOR THE SITING OF COMMUNICATIONS ANTENNAS

WHEREAS, the Township enacted Ordinance 2003-51, setting forth procedures for submission of applications for preliminary and final site plan approval of wireless telecommunication facilities within the Township; and

WHEREAS, the Township further set forth the details for such preliminary and final site plans for wireless telecommunications facilities in all commercial zones, as well as for wireless telecommunications facilities in the R-1, R-1/1, R-2, R-3, R-4, R-1/PN, SCC and OR Zones; and

WHEREAS, the Township also wishes to set forth that new wireless communications antennas and towers shall be located at the lowest numbered priority location as available within an applicant's search area, contingent upon maintaining the best level of service and at the same time benefitting the public's health, safety and welfare.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Township Council of the Township of West Milford, County of Passaic, and the State of New Jersey that Chapter 470, Subdivision of Land and Site Plan Review, Article XX Wireless Telecommunication Facilities shall be amended only to include a new Section 470-93.1 setting forth a priority of locations, as follows:

SECTION 1. ARTICLE XX, Wireless Telecommunications Facilities

§ 470-93.1 Purpose and Intent. The siting of any telecommunications facility shall be determined according to the lowest numbered priority location as set forth as within this Article, contingent upon such location providing an acceptable level of telecommunication service from the provider.

§ 470-93.2 Priority of Locations for Siting of Telecommunications Facilities

RESOLUTION OF THE TOWNSHIP OF WEST MILFORD, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AUTHORIZING PLANET NETWORKS, INC. TO USE NEW AND EXISTING POLES ERECTED WITHIN THE PUBLIC RIGHTS-OF-WAY FOR THE INSTALLATION OF TELECOMMUNICATIONS EQUIPMENT

WHEREAS, Planet Networks, Inc. ("Planet Networks") is a telecommunications services provider authorized by the New Jersey Board of Public Utilities to provide local exchange and interexchange telecommunications services throughout New Jersey; and

WHEREAS, in accordance with N.J.S.A. 48:3-19, N.J.S.A. 27:16-6 and N.J.S.A. 48:17-8, Planet Networks has petitioned the Township of West Milford for consent to use the public rights-of-way to place its telecommunication facilities aerially on existing and new utility poles and/or in underground conduit; and

WHEREAS, Planet Networks has or will enter into agreements with the utility companies for the use of their poles; and

WHEREAS, N.J.S.A. 48:3-19 provides that "[t]he consent of the municipality shall be obtained for the use by a person of the poles of another person unless each person has a lawful right to maintain poles in such street, highway or other public place."; and

WHEREAS, N.J.S.A. 27:16-6 provides, in part, that "[t]he board of chosen freeholders shall not grant an easement, right of way, or use in, under or over, any portion of a county road in a municipality, unless the governing body of the municipality, or the board of public utility commissioners, shall consent thereto. When, in connection with any such grant, the consent of property owners is required by law, it shall be obtained before such grant of any such easement, right of way or use."; and

WHEREAS, N.J.S.A. 48:17-8 provides that, "[a]ny telegraph or telephone company organized under the laws of this or any other State, or of the United States may erect, construct and maintain the necessary poles, wires, conduits, and other fixtures for its lines, in, upon, along, over or under any public street, road or highway, upon first obtaining the consent in writing of the owner of the soil to the erection of such poles, and through, across or under any of the waters within this State and upon, through or over any other land, subject to the right of the owners thereof to full compensation for the same"; and

WHEREAS, the Mayor and Township Council finds that it is in the best interest of the Township and its citizens to grant such consent to Planet Networks.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Council of the Township of West Milford, in the County of Passaic and State of New Jersey, that it does hereby grant permission and authority to Planet Networks to install fiber optic cables and related facilities on existing utility poles within the public rights-of-way and to install new utility poles, upon the following terms and conditions:

- Planet Networks shall adhere to all applicable federal, State, and local laws in connection with its use of the public right-of-way.
- 2. Planet Networks shall obtain any applicable permits in connection with the installation of its facilities;
- 3. Planet Networks shall indemnify, defend and hold harmless the municipality, its officials, agents, and employees, from and against any claim of liability, damages or loss resulting in bodily injury or property damage arising out of Planet Network's use of the public right-of-way, except to the extent such loss, injury or property damage resulting from the acts or omissions of the municipality.
- 4. Planet Networks shall procure and maintain, at its cost and expense, commercial general liability insurance with limits not less than \$1,000,000 for injury to or death of one or more persons in any one occurrence and \$500,000 for damage or destruction to property in any one occurrence and shall include the municipality as an additional insured on said insurance policy.
- 5. Planet Networks shall be responsible for the repair of any damage to pavement or any structure arising from its construction, installation or maintenance of its facilities.
- 6. Notwithstanding any provision contained herein, neither the municipality nor Planet Networks shall be liable to the other for consequential, incidental, exemplary, or punitive damages on account of any activity pursuant to this consent.
- 7. That the Mayor is hereby authorized to execute and the Clerk to attest to any other documents necessary to effectuate the terms of this resolution.
- 8. If a new utility pole is to be installed, Planet Networks, Inc., agrees to submit an escrow of \$750 for the application.
- 9. In addition, Planet Networks, Inc. shall provide an escrow of \$750 and reimburse the Township for any actual costs and any services rendered by the Township or its professionals in connection with the granting of this consent and use of the public right of way.
- 10. The term of this consent shall be fifteen (15) years.
- Planet Networks, Inc. will supply the Township in advance of the installation of the fiber optics with appropriate mapping and notification of the installation of the fiber optic at least fifteen (15) days before undertaking such work.
